<p style="text-align: center;">淡江真理社 葉宏毅</p>	<p>各項關於出外旅遊超過一天的活動，在活動申請時需要有紙本的家長簽名（家長同意書），但並不是每位社員家裡都是住在附近，並且假日也不容易回去，就會產生偽造簽名的問題，這樣也無法感受到家長同意書的意義，希望學校可以有好的方法解決，可將家長同意書改為學生切結書，並且需要告知父母，或是可改為線上的方式，不用紙本而改用表單回覆。本社目前的解決方式是請社員在同意書上填寫自己的姓名（因社員均年滿十八歲，為完全行為能力人），還需要傳訊息或電話告知家長會去的地點、時間和跟哪些人。</p>	<p style="text-align: center;">課外活動輔導組</p>	<p>因應民法部分條文修正，成年年齡下修至 18 歲，課外活動輔導組已修訂家長同意書相關規定：舉辦登山及過夜之校外活動，應先提出申請，核准後始得辦理。申請活動時未成年之同學需附上「學生參與社團活動未成年家長同意書」，成年之同學需附上「學生參與社團活動個人切結書」（切結書只須學生本人簽名），送課外活動輔導組核備。</p>

Currently there are no English version of “Club Activity Certification and Execution” for the international students to use, this issue has resulted in many international students being unable to successfully complete the necessary procedures on their own. Furthermore, the steps involved in activity certification and execution are complicated, and with the addition of language barriers, over time, the majority of international students will seek out assistance from local students for help in order for the international students to be able to complete the application and submission process. If this condition still goes on, it will not be fair for both the international students and the domestic students.</p>
